AN ORDINANCE TO AMEND CHAPTER 22; ZONING, SECTION 22-7; SITE DEVELOPMENT STANDARDS, SUBSECTION 22-7 4; SIGN REGULATIONS OF THE ST. BERNARD PARISH CODE OF ORDINANCES.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**SECTION 1.** The St. Bernard Parish Council does hereby amend Chapter 22; Zoning, Section 22-7; Site Development Standards Subsection 22-7-4; Sign Regulations of the St. Bernard Parish Code of Ordinances as attached in Exhibit "A".

**SECTION 2.** Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

**SECTION 3.** Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.







**EXHIBIT "A"**  
**SUMMARY NO. 3513**  
**ORDINANCE SBPC #1996-09-17**

*Chapter 22 – Zoning      Section 22-7 – Site Development Standards*  
*Subsection 22-7-4 – Sign Regulations*

*22-7-4.2. Definitions.*

*Billboard sign:* A freestanding sign used for selling advertising space, primarily off-premise advertising.

*22-7-4.5. Dimensions, conditions, and restrictions for sign types.*

*(h) Freestanding signs.*

- (1) The total number of billboards shall be limited to a number of 17.
- (2) Billboards signage shall be limited to 672 square feet per side.
- (3) An applicant must receive a resolution from the Parish Council to replace a billboard.
- (4) Billboards shall be a minimum height of 25 feet to the bottom of the sign.

*22-7-4.7. Application requirements and fee schedule.*

*(b) Fees.* When completed application is submitted with required information, a nonrefundable application fee shall be required according to the following schedule:

1. *Electrical signs:* Twenty-five dollars (\$25.00), plus electrical signs applicants shall pay an additional cost of an electrical inspection by either the St. Bernard Parish office of community development or its licensed designee.
2. *Non-electrical signs:* Twenty-five dollars (\$25.00).
3. *Murals:* Twenty-five dollars (\$25.00).
4. *Temporary signs:* Twenty-five dollars (\$25.00).
5. *Banners:* Twenty dollars (\$20.00).
6. *Billboards:* Five hundred dollar (\$500.00) All electrical sign applicants shall pay an additional cost for an electrical permit.
7. *Political signs.* Political signs shall be exempt from all fees.
