BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, OCTOBER 3, 2017 AT SEVEN O'CLOCK P.M.

On motion of Mr. Gorbaty, seconded by Mr. Montelongo, it was moved to **adopt** the following ordinance:

AN ORDINANCE AUTHORIZING THE PARISH PRESIDENT TO LEASE THE BOAT HOUSE LOCATED AT SIDNEY D. TORRES MEMORIAL PARK, JEAN LAFITTE PARKWAY, CHALMETTE, LA TO AN INDEPENDENT OPERATOR, TO OPERATE THE BOAT RENTALS AT THE PARK AND TO ALLOW THE OPERATOR TO OPERATE AN ADDITIONAL BUSINESS IN THE BOAT HOUSE.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

WHEREAS, it is in the best interest of the citizens of the St. Bernard Parish to lease the boat house located at Sidney D. Torres Memorial Park, Jean Lafitte Parkway to an independent operator to operate the boat rentals at the park and to allow the operator to operate an additional business in the boat house;

WHEREAS, La. R.S. 41:1212 *et. seq.* and St. Bernard Parish Home Rule Charter Section 2-11(11) authorizes the Parish to lease parish property;

WHEREAS, the present boat rental operation operates at a financial loss;

SECTION 1. St. Bernard Parish Council, the governing authority for St. Bernard Parish, does hereby authorize the parish president to lease the boat house located at Sidney D. Torres Memorial Park, Jean Lafitte Parkway to an independent operator to operate the boat rentals at the park and to allow the operator to operate an additional business in the boat house.

SECTION 2. The lessee shall be selected, using the bid procedures set forth in La. R.S 41:1212 *et. seq.*, and the Parish shall retain the right to reject all bids. The initial term of the lease shall be for three years. The business operation shall be complimentary and appropriate to the Park.

SECTION 3. The President of St. Bernard Parish Government is hereby authorized to execute any documents necessary to lease the above-referenced property in compliance with this ordinance.

SECTION 4. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 5. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:




