## RESOLUTION SBPC #1734-06-17

A RESOLUTION ADOPTING THE ST. BERNARD PARISH BIKEWAY AND PEDESTRIAN PLAN UPDATE.

WHEREAS, St. Bernard Parish Government has partnered with the Regional Planning Commission of Orleans, Jefferson, Plaquemines, St. Bernard, St. Charles, St. John, St. Tammany and Tangipahoa Parishes (RPC) to undertake an update of our 2014 community bikeway plan as adopted in the St. Bernard Parish Comprehensive Plan; and

WHEREAS, a plan update was in order due to the increased amount of bikeway facility planning that is currently underway in the Parish, additional grant funding that has been received for bikeway facilities; adoption of the new Complete Streets Policy and implementation ordinances; and the need to address pedestrian improvements more fully than what was identified in the Parish Comprehensive Plan; and

WHEREAS, the RPC was able to secure a \$40,000.00 grant for St. Bernard Parish to undertake this work with the assistance of a consultant team composed of Soll Planning of New Orleans and Alta Planning and Design of Portland, Oregon; and

WHEREAS, St. Bernard Parish Government formed a Technical Advisory Committee to assist with the preparation of the plan including local and regional planning, engineering, and GIS professionals; local elected officials; and advocates for bicycling, accessibility, and transit interests, and

WHEREAS, the Technical Advisory Committee participated in the plan development process including developing the methodology, technical analysis, and plan recommendations; and


