## RESOLUTION SBPC #1755-09-17

A RESOLUTION REQUESTING THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (LADOTD) TO INSTALL AN INTERSECTION CONTROL BEACON AT THE INTERSECTION OFF OF LOUISIANA STATE HIGHWAY 46 AND ARCHBISHOP HANNAN BOULEVARD.

WHEREAS, The St. Bernard Parish Council, the Governing Authority is requesting the Louisiana Department of Transportation and Development to install an intersection control beacon at the intersection of Louisiana State Highway 46 and Louisiana Archbishop Hannan Boulevard to promote the health, safety, and welfare of citizens who travel said Highway, and;

WHEREAS, in order to preserve our continued recovery efforts, and;

WHEREAS, there is a desire of the habitants and travelers of said road requesting it to be safer for passing through, and;

WHEREAS, the Governing Authority desires to provide a safer environment for the habitants and travelers.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority, does hereby request the Louisiana Department of Transportation and Development install an intersection control beacon at the intersection of Louisiana State Highway 46 and Archbishop Hannan Boulevard.


