BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, SEPTEMBER 19, 2017 AT THREE O'CLOCK P.M.

On motion of Mr. Gorbaty, seconded by Mr. Montelongo, it was moved to adopt the following resolution:

## RESOLUTION SBPC #1758-09-17

A RESOLUTION AUTHORIZING ACCEPTANCE OF A 2016-2018 FEDERAL TRANSPORTATION ALTERNATIVES PROGRAM GRANT FOR CONSTRUCTION OF THE ST. BERNARD MISSISSIPPI TRAIL PHASE IV IN THE AMOUNT OF \$582,384.00.

WHEREAS, the federal transportation act, known as The Moving Ahead for Progress in the 21st Century Act (MAP-21), authorized the Transportation Alternatives Program (TAP) to provide funding for programs and projects defined as transportation alternatives including on- and off-road pedestrian and bicycle facilities and recreational trail projects; and

WHEREAS, the TAP program in Louisiana is administered by the Louisiana Department of Transportation and Development (DOTD); and

WHEREAS, DOTD issued a call for competitive grant applications and St. Bernard Parish Government submitted an application to fund construction of a two-mile long 10 ft. wide multi-purpose path from Valero Refinery west to Paris Road known as the Mississippi River Trail Phase IV as authorized by Parish Council resolution in October, 2016; and

WHEREAS, DOTD has conditionally approved funding for 34 projects totaling over \$14,000,000.00; and

WHEREAS, St. Bernard Parish's application for the Mississippi River Trail Phase IV was selected for conditional approval; and

WHEREAS, DOTD requires that St. Bernard Parish certify its acceptance of this grant by adoption of a Council resolution approving the conditions for acceptance.

NOW THEREFORE BE IT RESOLVED the St. Bernard Parish Council does hereby authorize the acceptance of this Transportation Alternatives Program 2016-2018 grant for the St. Bernard Mississippi River Trail Phase IV; and

- 3) That St. Bernard will be responsible for any legal liability incurred as a result of the project.

**BE IT FURTHER RESOLVED**, the St. Bernard Parish Council, does hereby authorize the President of St. Bernard Parish Government to sign and execute all required grant agreements and any amendments thereof, and all of the necessary reports, assurances, contracts and any other documents required in connection with this Transportation Alternatives Program Grant.
