AN ORDINANCE TO AMEND CHAPTER 10; FIRE PROTECTION AND PREVENTION, ARTICLE II; FIRE PREVENTION CODE, SECTION 10-23; PERMIT AND INSPECTION FEES OF THE ST. BERNARD PARISH CODE OF ORDINANCES.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The Parish Council hereby amend Chapter 10; Fire Protection and Prevention, Article II; Fire Prevention Code, Section 10-23; Permit and inspection fees as attached in Exhibit "A".

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion of this Ordinance with the invalid portions omitted.

Chapter 10 - Fire Protection and Prevention Article II - Fire Prevention Code

Section 10-23 - Permit and inspection fees

The fire prevention code is amended to include the following schedules of permit and inspection fees:

III. Fuel Filling Station Fire Inspection Fee.

St. Bernard Parish Fuel Filling Stations will be required to pay an annual fire inspection fee as follows:

	<i>Fuel Filling Stations</i>	<i>Annual Cost</i>
(1)	8 filling positions or greater	\$500.00
(2)	4 to 7 filling positions	\$250.00
(3)	1 to 3 filling positions	\$125.00

IV. Fire Incident Report Fee

The St. Bernard Parish Fire Department shall charge and collect a \$35.00 fee per copy of a Fire Incident Report.
