The Parks and Parkways Commission met on Monday, February 19th and discussed several projects. The following projects were approved:

- Up to \$2640 for sod from a current parish contractor for the Patricia Park project led by Councilman McCloskey.
- Up to \$2360 for trees from a to-be-determined vendor for the Patricia Park project led by Councilman McCloskey.
- Up to \$2400 for trees from a to-be-determined vendor for the 40 Arpent Greenway project led by Councilman Luna.

We believe these projects will bring much needed green space development to their respective neighborhoods and support funding them.

40 Arpent Greenway Tree Planting

Currently, there is no canopy of trees along the greenway. An upgrade to the existing lighting has started with the help of Entergy and the Government Administration. This tree planting is another phase in the project to develop the greenway into an outdoor attraction for existing and potential residents. And for those visiting Val Reiss park. The greenway is also a part of the St. Bernard Bike Plan and the 40 arpent Bike and Ped trail.

To enhance the attractiveness of the greenway the plan is to plant local varieties of trees along the stretch that runs between Gallo and Jacob Drive, and between Florida Avenue and the 40 arpent canal. We plan to use Cypress, Willows and Swamp Red Maples. The attached plan shows the locations of these trees along the greenway.

The planting will be accomplished using parish equipment and employees to dig the holes and local residents to help with the planting and care of the trees. The holes will be dug on a Friday and the planting done on a Saturday.

The cost of the project is about \$2400. This amount is based on an average cost per tree of \$100. The number needs to be confirmed, but we will adjust the size of the trees to fit this amount.

The timing of this project (and any tree project) is critical. Trees that are placed on public property with little or no maintenance are better planted in the winter or early spring.
