BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, MARCH 6, 2018 AT SEVEN O'CLOCK P.M.

On motion of the Chair without objection and by unanimous consent, it was moved to **remove** the following resolution from the agenda:

### RESOLUTION SBPC #1803-03-18

A RESOLUTION AUTHORIZING AN APPLICATION TO APPROVE THE BLUEBIRD PARK REDEVELOPMENT PROJECT AT 30 E. CHALMETTE CIRCLE, WHICH IS OWNED AND MANAGED BY ST. BERNARD PARISH GOVERNMENT AND EXEMPTING THE PROJECT FROM STRICT COMPLIANCE WITH THE COMPREHENSIVE ZONING ORDINANCE PURSUANT TO CHAPTER 5, SECTION 5-21. – EXEMPTION OF GOVERNMENT BUILDINGS AND LAND AND SCHOOLS WITH ENROLLMENT OF 500 OR MORE STUDENTS. THE PROPERTY IS DESIGNATED AS 30 E. CHALMETTE CIRCLE.

**WHEREAS**, a need exists for the redevelopment of Bluebird Park, located at 30 E. Chalmette Circle, Lot 24, Sq. 3 Sec C Chal Vista (hereinafter "Bluebird Park"), as a park containing special accessible equipment to meet the needs of persons with disabilities, and;

**WHEREAS**, Bluebird Park is owned by St. Bernard Parish Government and an exemption from the strict compliance of the Comprehensive Zoning Ordinance is needed for the redevelopment of Bluebird Park, and;

**WHEREAS**, the proposed perimeter fencing height/setback and designated parking lot area setbacks contained in the Bluebird Park redevelopment project will not negatively impact the adjacent and surrounding residentially zoned properties; and

**WHEREAS**, the project is funded by a \$300,000 Community Development Block Grant (CDBG) and \$250,000 from St. Bernard Parish Government (SBPG) for a total and approved budget of \$550,000.

**NOW THEREFORE BE IT RESOLVED** the St. Bernard Parish Council, does hereby approve and exempt the Bluebird Park redevelopment project from strict compliance with the Comprehensive Zoning Code, subject to the requirements
