On motion of Mr. Montelongo, seconded by Mr. Gorbaty, it was moved to adopt the following resolution:

RESOLUTION SBPC #1807-03-18

A RESOLUTION TO APPROVE THE BUCCANEER VILLA NORTH FORTY ARPENT LAGOON PARK PROJECT AND TO APPROVE AN APPLICATION FOR THE U.S. PARK SERVICE LAND AND WATER CONSERVATION FUND GRANT IN THE AMOUNT OF \$250,000 FOR THE PROJECT.

WHEREAS, the Parish is improving quality of life by developing park space in St. Bernard Parish; and,

WHEREAS, the project would create an amenity that reduces flooding in an adjacent neighborhood with severe repetitive loss properties; and,

WHEREAS, the Parish's Comprehensive Plan and Integrated Water Resources Management Plan promotes development of the park.

NOW THEREFORE BE IT RESOLVED the St. Bernard Parish Council, does hereby authorize the submission of an application to the U.S. Park Service Land and Water Conservation Fund in the amount of \$250,000; and, approve the Buccaneer Villa North Forty Arpent Lagoon Park Project; and,

BE IT FURTHER RESOLVED, the St. Bernard Parish Council, does hereby authorize the President of St. Bernard Parish Government to sign and execute all required applications and agreements and any amendments thereof, and all of the necessary reports, assurances, contracts and any other documents required in connection with the U.S. Park Service Land and Water Conservation Fund Grant.


The Council Chair, Ms. Callais, cast her vote as **YEA**.
