AN ORDINANCE TO APPROVE **DOCKET Z-2018-015**, PETITION OF MICHAEL STOUT FOR A CONDITIONAL USE PERMIT TO OPERATE A SEAFOOD TRANSFER STATION IN AN A-1, (RURAL) DISTRICT. PROPERTY LOCATION: 6017 DELACROIX HWY. ST. BERNARD, LA 70085.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The St. Bernard Parish Council does hereby approve **Docket Z-2018-015**, petition of Michael Stout for a Conditional Use Permit to operate a Seafood Transfer Station in an A-1, (Rural) District.

Property Location: 6017 Delacroix Hwy. St. Bernard, LA 70085.

Planning Commission recommends Approval with the following WAIVERS and CONDITIONS:

WAIVERS:

1. A waiver of the requirements of Section 22-7-3.4- Parking lot design to include front loading and side setbacks as well as travel lane reductions to those shown on the site plan.

CONDITIONS:

1. Landscaped buffer along side property lines
2. Waste treatment systems to be located at the rear of the property (as required)
3. Commercial Dumpster (with screening) for site operations to be located at the rear of the property
4. An Occupational License shall be required for the business.
5. Detailed plan for site lighting and utilities
6. The applicant shall insure that Cold Storage, Van, and Bathrooms are either mobile or elevated. All restroom facilities shall be ADA compliant.

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:






