BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, AUGUST 21, 2018 AT THREE O'CLOCK P.M.

On motion of Mr. McCloskey, seconded by Ms. Callais, it was moved to adopt the following resolution:

RESOLUTION SBPC #1869-08-18

A RESOLUTION SUPPORTING THE PARISH PRESIDENT TO SUBMIT GRASS CUTTING CHARGES FOR GRASS CUTTING AND REMOVAL TO BE ADDED TO THE 2017 ANNUAL AD VALOREM TAX BILL OF THE NON-ADJUDICATED PROPERTIES INVOLVED.

WHEREAS, the Parish is improving the quality of life of its residents by maintaining lots in St. Bernard Parish; and,

WHEREAS, the placement of liens on the ad valorem tax bills of non-adjudicated properties for grass cutting and removal will promote redevelopment, lot maintenance, and assist in recovering costs incurred by the Parish; and,

WHEREAS, St. Bernard Parish Government is authorized by La. R.S. 33:1236 and Chapter 11 Sec. 11-2 of the St. Bernard Parish Code of Ordinances to have the charges associated with grass cutting and removal placed on the annual ad valorem tax bills of the properties involved.

NOW THEREFORE BE IT RESOLVED the St. Bernard Parish Council, the governing authority, does hereby support the placement of outstanding grass liens for grass cutting and removal charges on the ad valorem tax bills for 2017 on non-adjudicated properties.

BE IT FURTHER RESOLVED, the St. Bernard Parish Council, does hereby authorize the President of St. Bernard Parish Government to submit the non-adjudicated properties with lien amounts for grass cutting and removal charges to the St. Bernard Parish Assessor, and to sign and execute all documents necessary for the placement of the said amounts on the 2017 ad valorem tax bills for non-adjudicated properties.
