On motion of Mr. Montelongo, seconded by Mrs. Alcon, it was moved to adopt the following resolution:

RESOLUTION SBPC #1882-10-18

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO SUBMIT A LOAN PRE-APPLICATION AND ACCOMPANYING DOCUMENTS TO THE LOUISIANA DEPARTMENT OF ENVIRONMENTAL QUALITY ON BEHALF OF ST. BERNARD PARISH FOR THE PURPOSE OF REPAIR AND REHABILITATION OF THE SANITARY SEWER GRAVITY COLLECTION SYSTEM OF THE ST. BERNARD PARISH SEWER DISTRICT.

WHEREAS, St. Bernard Parish has completed improvements to the St. Bernard Parish Sewer District utilizing LDEQ SRF Loan funds.

WHEREAS, previously sewer rate increases were provided to implement sewer capital repairs, and St. Bernard Parish remains in need of improvements to the St. Bernard Parish Sewer District;

WHEREAS, loans and/or grants for this project may be available through the State Revolving Fund loan program operated by the Louisiana Department of Environmental Quality.

NOW, THEREFORE, BE IT RESOLVED by the St. Bernard Parish Council, acting as governing authority of said Parish

SECTION 1. That Guy McInnis, Parish President, is hereby authorized to submit a pre-application to the Department of Environmental Quality on behalf of St. Bernard Parish for the purpose of placing this project on the Project Priority List for funding through the State Revolving Fund loan program; and,

SECTION 2. The Parish President is further authorized to furnish such additional information as may reasonably be requested in connection with the pre-application; and,

SECTION 3. That Keith LaGrange is hereby designated as the Office Project Representative for St. Bernard Parish for any project that may result from the submission of the pre-application.


