On motion of Mr. Luna, seconded by Mr. Lewis, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #1861-07-18

A RESOLUTION AUTHORIZING A GRANT APPLICATION TO THE LOUISIANA LOCAL GOVERNMENT ASSISTANCE PROGRAM FOR FY2018-2019 IN THE AMOUNT OF \$77,800.00 FOR THE FORTY ARPENT CANAL FISHING PIER

WHEREAS, the FY 2018-19 Louisiana Local Government Assistance Program (LGAP) is a State of Louisiana program designed to provide financial assistance in support of projects which improve the health, safety and quality of life of the residents in selected geographical areas; and

WHEREAS, St. Bernard Parish adopted a new Bikeway and Pedestrian Plan in 2017 that includes development of a major multi-purpose trail known as the 40 Arpent Trail along the 40 Arpent Canal Corridor; and

WHEREAS, in conjunction with this corridor development, the Parish is preparing plans and seeking funding for additional improvements that will enhance the trail corridor, improve neighborhood access, expand recreational amenities, and improve the quality of life of our residents; and

WHEREAS, construction of a new recreational fishing pier along the Forty Arpent Canal in Arabi has been selected as one of these projects; and

WHEREAS, the Louisiana Local Government Assistance Program has issued a call for grant applications for its 2018-2019 State program with grants not to exceed \$77,800.00 with no local matching funds required

NOW THEREFORE BE IT RESOLVED that the St. Bernard Parish Council, does hereby authorize the submission of a FY2018-2019 grant application to the State of Louisiana Local Government Assistance Program in the amount of \$77,800.00 for the Forty Arpent Canal Fishing Pier; and

BE IT FURTHER RESOLVED, that the St. Bernard Parish Council does hereby authorize the President of St. Bernard Parish Government to sign and submit all required grant applications, Cooperative Endeavor Agreements and any amendments thereof, and all of the necessary reports, assurances, contracts and any other documents required in connection with the LGAP Program.


The Council Chair, Ms. Callais, cast her vote as **YEA**.
