On motion of Mr. McCloskey, seconded by Mr. Gorbaty, it was moved to adopt the following ordinance:

AN ORDINANCE NAMING FIELD #5 AT THE VAL RIESS COMPLEX AS "SAMMY FRICHTER, SR. FIELD".

WHEREAS, the Parish Council believes it to be in the best interest of the citizens of St. Bernard Parish and St. Bernard Parish Government to name Field #5 at the Val Riess Complex as "Sammy Frichter, Sr. Field"; and,

WHEREAS, Mr. Sammy Frichter, Sr. dedicated his life to providing recreation to the children and citizens of St. Bernard Parish; and,

WHEREAS, Mr. Sammy Frichter, Sr., the former namesake of Vista Gymnasium, had dedicated his life to St. Bernard Recreations.

WHEREAS, the Sammy Frichter Gymnasium no longer exists.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The St. Bernard Parish Council, the governing authority for St. Bernard Parish, does hereby ordain and decree that Field #5 at the Val Riess Complex shall be named and hereinafter forever known as "SAMMY FRICHTER, SR. FIELD."

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion of this Ordinance with the invalid portions omitted.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:




