## **RESOLUTION SBPC #1896-12-18**

A RESOLUTION SUPPORTING THE INTRODUCTION AND PASSAGE OF LEGISLATION TO ENABLE ST. BERNARD PARISH TO IMPOSE AND COLLECT A HOTEL/MOTEL TAX TO SUPPLEMENT THE FUNDING OF THE ST. BERNARD PARISH FIRE DEPARTMENT.

**WHEREAS**, the Louisiana State Legislature has the authority to enact legislation that would allow St. Bernard Parish to impose and collect a Hotel/Motel Tax within the confines of St. Bernard Parish in order to supplement the funding of the St. Bernard Parish Fire Department; and,

**WHEREAS**, the St. Bernard Parish Fire Department needs additional funding to improve the fire protection service provided to the citizens of St. Bernard; and,

**WHEREAS**, it is in the best interest of the citizens of St. Bernard Parish for the state Legislature to enact legislation authorizing the imposition and collection of a Hotel/Motel Tax in St. Bernard Parish in order to supplement the funding of the St. Bernard Parish Fire Department.

**NOW THEREFORE, BE IT RESOLVED**, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, supports LA State Representative Raymond E. Garofalo, Jr.'s efforts to introduce and pass legislation authorizing the imposition and collection of a Hotel/Motel Tax in St. Bernard Parish of \$3.00 per night, with a cap of \$5.00, upon a vote of the citizens, in order to supplement the funding of the St. Bernard Parish Fire Department of St. Bernard Parish.
