On motion of Mr. Luna, seconded by Mrs. Alcon, it was moved to **adopt** the following ordinance:

## ORDINANCE SBPC #2194-09-19

### Summary No. 3750

Introduced by: Councilmember Luna on 9/3/19

AN ORDINANCE LEVYING AND IMPOSING A TAX OF ONE PERCENT (1%) OF THE GROSS TRIP FARE FOR EACH INTRASTATE PREARRANGED RIDE BY TRANSPORT NETWORK COMPANIES, NAMELY, UBER AND LYFT.

**WHEREAS**, under the authority of La. R. S. 48:2204, a local governmental subdivision may impose a fee of up to one percent of the gross trip fare for each intrastate prearranged ride; and,

**WHEREAS**, a parish's fee may apply only to intrastate prearranged rides originating within the unincorporated portions of the parish; and,

**WHEREAS**, it is in the best interest of St. Bernard Parish to assess a tax of one percent (1%) of the gross trip fare for each intrastate prearranged ride by transport network companies, namely Uber and Lyft.

**NOW, THEREFORE, BE IT ORDAINED** by St. Bernard Parish Council, a local governmental subdivision, that a tax of one percent (1%) of the gross trip fare is hereby levied, assessed and imposed on each intrastate prearranged ride by transport network companies, namely Uber and Lyft.

**SECTION 1. Effective Date.** This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

**SECTION 2. Severability.** If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.




