On motion of the Chair, without objection and by unanimous consent, it was moved to **REMOVE** the following resolution from the agenda:

## **RESOLUTION SBPC #2093-01-21**

A RESOLUTION AUTHORIZING ST. BERNARD PARISH TO PREPARE AND SUBMIT A PRE-APPLICATION TO THE STATEWIDE FLOOD CONTROL PROGRAM FOR ASSISTANCE IN THE IMPLEMENTATION OF DRAINAGE IMPROVEMENTS TO OLD ARABI FOR THE PURPOSE OF REDUCING EXISTING FLOOD DAMAGES; PROVIDING FOR THE NECESSARY DOCUMENTATION OF SAID FLOOD DAMAGES; AND PROVIDING FOR OTHER RELATED MATTERS IN CONNECTION THEREWITH.

**WHEREAS**, Old Arabi has been adversely affected by damages from flood waters; and,

**WHEREAS**, St. Bernard Parish desires to apply for State matching funds pursuant to L.A. R.S. 38:90.1 et seq., as amended, to implement a project to reduce said flood damages, and that St. Bernard Parish is fully aware of its obligations under said Statute; and,

**WHEREAS**, St. Bernard Parish is a political body duly organized and existing under the laws of the State of Louisiana and is eligible to apply for funds under the Statute.

**NOW THEREFORE BE IT RESOLVED**, the St. Bernard Parish Council, the Governing Authority, does hereby do as follows:

**SECTION 1.** St. Bernard Parish acknowledges that upon approval of the pre-application a formal application will be prepared and submitted to the Statewide Flood Control Program.

**SECTION 2.** At the appropriate time and upon approval of funding assistance and prior to commencement of work on the project St. Bernard Parish agrees to execute a Statement of Sponsorship pursuant to said Statute.
