On motion of Mr. McCloskey, seconded by Mr. Moran, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #2326-09-23

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO EXECUTE THOSE DOCUMENTS AND AGREEMENTS REQUIRED IN IMPLEMENTING THE GRANT UNDER THE COMMUNITY DEVELOPMENT BLOCK GRANT DISASTER RECOVERY PROGRAM THROUGH THE RESTORE LOUISIANA INFRASTRUCTURE: FEMA PUBLIC ASSISTANCE NONFEDERAL SHARE MATCH PROGRAM FOR ST. BERNARD PARISH IN THE AFTERMATH OF HURRICANE IDA.

WHEREAS, St. Bernard Parish Government has submitted an application for funding under the Community Development Block Grant Disaster Recovery (CDBG-DR) Infrastructure Program; and,

WHEREAS, the Department of Housing & Urban Development regulations require that St. Bernard Parish Government certify that these activities for which CDBG funds are being requested are designed to alleviate existing conditions which pose a serious and immediate threat to the health or welfare of the community; which are of recent origin or which recently became urgent, and that the Parish is unable to finance the activity on its own, and that no other funds are available; and,

NOW THEREFORE BE IT RESOLVED that the St. Bernard Parish Council, as the governing authority of St. Bernard Parish, does hereby authorize the acceptance of funding and certifies that the activities for which CDBG funds in the amount of \$105,986.85 are being requested for the St. Bernard Parish Debris – Silt and Marsh Grass Public Assistance project are designed to provide the expeditious and effective recovery of public services in Louisiana and will meet the national objectives of benefitting persons of Low to Moderate income, Urgent Need and elimination of slum and blight and will result in a public benefit to the citizens of St. Bernard Parish.
