A RESOLUTION RESPECTFULLY REQUESTING THAT ADMINISTRATION ISSUE A REQUEST FOR INFORMATION (RFI) FROM AN ARCHITECTURAL LANDSCAPING FIRM FOR SCHEMATIC DESIGN AND PLANNING FOR THE VILLAGE SQUARE REVITALIZATION DEVELOPMENT.

WHEREAS, the plan to be provided needs to be consistent with the Village Square Revitalization Development provided in Ordinance SBPC #2523-09-23; and,

WHEREAS, all plans for the development should provide connectivity through all phases of individual projects and cohesively fit with the needs of the community and the St. Bernard Comprehensive Plan for green space amenities; and,

WHEREAS, information for the entire scope of the development should be provided with fiscal and construction break points; and,
