A RESOLUTION AUTHORIZING ACCEPTANCE OF GRANT FROM ATMOS ENERGY IN THE AMOUNT OF \$4,000.00 FOR THE 2018 JAZZ IN JUNE CONCERT SERIES AT TORRES PARK

WHEREAS, St. Bernard Parish Council authorized submission of a \$5,000 grant application to the Louisiana Department of Culture, Recreation and Tourism, Division of the Arts' Decentralized Arts Funding Program to fund the 2018 *Jazz in June* Concert Series; and

WHEREAS, the Louisiana Decentralized Arts Funding Program notified the Parish it was awarding a grant of \$1,000.00 for this program which the Parish accepted in September, 2017; and,

WHEREAS, ATMOS Energy expressed interest in providing funding support and a request was submitted by the Parish to ATMOS in September, 2017.

NOW THEREFORE BE IT RESOLVED, the St. Bernard Parish Council does hereby authorize acceptance of a grant from ATMOS Energy in the amount of \$4,000.00 for sponsorship of the 2018 *Jazz in June* concert series in Torres Park.

BE IT FURTHER RESOLVED, the St. Bernard Parish Council, does hereby authorize the President of St. Bernard Parish Government to sign and execute all required documents in connection with this grant.
