A RESOLUTION AUTHORIZING ACCEPTANCE OF AN FY2016-201 LOUISIANA COMMUNITY WATER ENRICHMENT GRANT FOR THE CENTER STREET WATER LINE IMPROVEMENT PROJECT IN THE AMOUNT OF \$122,074.00.

WHEREAS, the Louisiana Community Water Enrichment Program was established to assist local governments with funding to rehabilitate, improve, and construct projects that help the community water system provide safe and clean drinking water; and

WHEREAS, the Louisiana Community Water Enrichment grant program is administered by the Louisiana Division of Administration, Office of Community Development; and

WHEREAS, the Louisiana Office of Community Development issued a call for grant applications and St. Bernard Parish Government submitted an application to fund the Center Street Water Line Improvement Project; and

WHEREAS, the State of Louisiana has approved the Parish's application for the Center Street Water Line Improvement Project in the amount of \$122,074.00; and

WHEREAS, this grant provides 100% funding with no local matching funds required by the St. Bernard Parish; and

WHEREAS, St. Bernard Parish Government wishes to certify acceptance of this grant by adoption of this Council resolution.


