A RESOLUTION AUTHORIZING ACCEPTANCE OF A BYRNE JUSTICE ASSISTANCE PROGRAM GRANT FOR CRIMINAL JUSTICE TECHNOLOGY UPGRADES FOR 34TH JUDICIAL DISTRICT COURT IN THE AMOUNT OF \$3,300.00.

WHEREAS, the Louisiana Commission on Law Enforcement and Administration of Criminal Justice issued a call for projects with federal grant funding provided by U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance grant funding; and

WHEREAS, the primary purpose of this program is to provide funding to state and local government to support components of the criminal justice system for crime prevention; drug and gang task forces; violence programs; courts; corrections; treatment; and justice information sharing technology initiatives; and

WHEREAS, St. Bernard Parish Government submitted an application to fund Criminal Justice Technology Upgrades for the 34th Judicial District Court as authorized by the St. Bernard Parish Council in December, 2016; and

WHEREAS, this grant will be used to fund laptop computers for the operation of the Magistrate Court of the 34th Judicial District; and

WHEREAS, St. Bernard Parish's grant application for Criminal Justice Technology Upgrades was approved in April, 2017.

NOW THEREFORE BE IT RESOLVED the St. Bernard Parish Council, does hereby authorize the acceptance of this 2017 Edward Byrne Memorial Justice Assistance Program Grant as administered by the Louisiana Commission on Law Enforcement Grant for Criminal Justice Technology Upgrades for the 34th Judicial District Court in the amount of \$3,300.00 grant (no local matching funds required); and


