A RESOLUTION APPOINTING A NEW MEMBER AS THE COLLEGE BOARD MEMBER OF THE ST. BERNARD PARISH FIRE PROTECTION DISTRICTS NO. 1-2, FIRE CIVIL SERVICE BOARD.

WHEREAS, a vacancy exists on the St. Bernard Fire Protection Districts No. 1-2 Civil Service Board due the expired term of Daniel Solis; and

WHEREAS, the Council is desirous of filling the aforementioned vacancy.


