AN ORDINANCE TO APPROVE DOCKET Z-2017-001, PETITION OF JAMES LICCIARDI FOR A CONDITIONAL USE PERMIT TO OPERATE AN OFF TRACK BETTING FOR THE PROPERTY LOCATED AT 4242 E. JUDGE PEREZ DRIVE, MERAUX, LA 70075.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. That DOCKET Z-2017-001, Petition of James Licciardi for a Conditional Use Permit is hereby approved with conditions for the following described property:

Property Location: 4242 E. Judge Perez Drive, Meraux, LA 70075.

Planning Commission recommendation: **APPROVAL** with all conditions as described below:

1. A detailed landscape plan, prepared by a Louisiana Licensed Landscape Architect, subject to the conditions of **Section 22-7-1 – Landscape Regulations**.
2. Pickup/Dropoff areas, Loading Zones and a Fire Lane shall be shown on the site plan.
3. A drainage study shall be approved by the Department of Public Works.
4. All signage shall be submitted and approved by the Department of Community Development.

5. The applicant shall submit building elevation plans for exterior design and lighting, subject to the review and approval of the Department of Community Development.
6. The applicant shall secure all local and State gaming licenses prior to the issuance of the Certificate of Occupancy.

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:
