AN ORDINANCE TO AMEND CHAPTER 17; PERSONNEL, SECTION 17-31; ALCOHOL AND/OR DRUG TESTING OF EMPLOYEES IN THE ST. BERNARD PARISH CODE OF ORDINANCES.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The St. Bernard Parish Council, as the Governing Authority of the Parish, does hereby amend Chapter 17; Personnel, Section 17-31; Alcohol and/or drug testing of employees in the St. Bernard Parish Code of Ordinances as attached as Exhibit "A."

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.





CHAPTER 17 – PERSONNEL

SECTION 17-31 – ALCOHOL AND/OR DRUG TESTING OF EMPLOYEES

Sec. 17-31. - Alcohol and/or drug testing of employees.

- (a) All classified and unclassified employees (all employees) subject to this section shall be required to submit to a random drug-screening urinalysis when requested to do so by the Director of Human Resource. This test shall be given on a random basis without any prior notice to employees.
