AN ORDINANCE TO AUTHORIZE THE RETENTION OF AND PAYMENT OF ATTORNEY MICHAEL J. WINSBERG AND THE LAW OFFICE OF MICHAEL J. WINSBERG FOR THE PROVISION OF LEGAL SERVICES TO PARISH PRESIDENT GUY MCINNIS IN CONNECTION WITH A GRAND JURY SUBPOENA IN 34<sup>th</sup> JDC NO. 2016-04339, DIV. C.

ST. BERNARD PARISH COUNSEL DOES HEREBY ORDAIN:

**SECTION I.** St. Bernard parish Council, the governing authority, does hereby approve, authorize and ratify, the employment and payment of Attorney Michael J. Winsberg and the Law Office of Michael J. Winsberg for the provision of legal services to Parish President Guy Mcinnis in connection with grand jury subpoena in 34<sup>th</sup> JDC no. 2016-04339, Div. C.

**SECTION II.** Salary. The compensation shall be at the rates not to exceed the maximum hourly fee schedule from the attorney general.

**SECTION III.** The parish president is hereby authorized to enter a contract for legal services at rates not to exceed the maximum hourly fee schedule from the attorney general and in accordance with section 4-02 (b) of the home rule charter.

**SECTION IV.** Effective date. This ordinance shall become effective immediately upon authorizing signature by the parish president. In the event of a presidential veto, this ordinance shall become effective upon a two-thirds favorable vote of the total membership of the council pursuant to sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

**SECTION V.** Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this ordinance. The St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion of this ordinance with the invalid portions omitted.
