AN ORDINANCE TO APPROVE **DOCKET Z-2015-014**, PETITION OF JOSEPH SERPAS FOR A ZONING CHANGE FROM "R-1, (SINGLE FAMILY RESIDENTIAL)" TO "C-1, (NEIGHBORHOOD COMMERCIAL)" FOR THE PROPERTY DESIGNATED AS 1414 CENTER ST. ARABI, LA 70032.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. That **DOCKET Z-2015-014**, petition of Joseph Serpas for a Zoning Change from "R-1, (Single Family Residential)" to "C-1, (Neighborhood Commercial)" for the following described property:

One certain lot of ground situated in the Parish of St. Bernard, St. Claude Heights Subdivision, Block "L", designated as lot 24-A. Property designated as 1414 Center St. Arabi, La 70032.

Conditions:

1. The exterior must be completed within five (5) years according to plan.

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.
