

CANALS MAINTAINED BY
LAKE BORGNE BASIN LEVEE DISTRICT

East Railroad Ditch: Also called East/West Railroad Ditch(es); runs perpendicular to Judge Perez Drive; originates near St. Bernard Hwy. (adjacent to Bowling Alley near Eickes Canal) and parallels the Norfolk Southern Railroad Tracks to the Forty Arpent Canal and is bounded by Alexander on the Eastside (Paris Road side).

West Railroad Ditch: Also called East/West Railroad Ditch(es); runs perpendicular to Judge Perez Drive; originates at St. Bernard Hwy. (adjacent to Trist Bldg) and parallels the Norfolk Southern Railroad Tracks to the Forty Arpent Canal and is bounded by Aycock Street on the Westside (New Orleans side).

Eickes Canal: Runs perpendicular to Judge Perez Drive from St. Bernard Hwy. to the Forty Arpent Canal and is bounded by Center Street on the Westside (New Orleans Side) and by Schnell Drive on the Eastside (Paris Road side).

Eickes Canal Extension: Runs perpendicular to St. Bernard Hwy. from St. Bernard Hwy. to N. Peters and is bounded by an open field on the Eastside (Paris Road side) and by Center Street on the Westside (New Orleans side).

Guerenger Canal: Runs perpendicular to Judge Perez Drive from St. Bernard Hwy. to the Forty Arpent Canal; between St. Bernard Hwy. & Judge Perez, it is bounded on the Westside (New Orleans side) by Norton Street and on the Eastside (Paris Road side) by open land/no street; from Judge Perez Drive to the Forty Arpent Canal, it is bounded on the Westside (New Orleans Side) by Cougar Street and on the Eastside (Paris Road side) by open land/no street.

Fortification Canal: Runs perpendicular to Judge Perez Drive from 8th Street to the Bluebird Lateral Canal and is bounded by Artillery on the Eastside (Paris Road side) and by Andrew Jackson High School on the Westside (New Orleans side); from 8th Street to St. Bernard Highway belongs to Parish.

Note: Creely Canal (a.k.a. Tiger Town) runs from the Bluebird Lateral Canal to St. Bernard Hwy.; Creely Canal also belongs to the Parish. It is bounded by Andrew Jackson High School and Artillery on the Eastside (Paris Road side) and by Creely on the Westside (New Orleans side).

Chalmette Vista Canal: Runs perpendicular to Judge Perez Drive from the Bluebird Lateral Canal to the Forty Arpent Canal and is bounded by Kings Drive on the Westside (New Orleans side) and by open land on the Eastside (Paris Road side).

Guichard Canal: Runs perpendicular to Judge Perez Drive from St. Bernard Hwy. (at Packenham Trailer Park behind Dr. York's office) to the Forty Arpent Canal and is bounded by Jupiter on the Westside (New Orleans side) and by Packenham Drive on the Eastside (Paris Road side).

Canal Extension: Same Channel constructed in two stages. Runs parallel to Judge Perez Drive. Starts at Joe Meraux's empty lot next to Arby's and runs to the rear of Luther's Restaurant and is bounded on the Northside (Lakeside) by the rear of Shoney's and Schwegmann's; no streets are involved. It is bounded on the Southside (Riverside) by Colonel and East Claiborne Square/West Claiborne Square.

Florida Walk Canal: Also called the Forty Arpent Canal. Runs parallel to Judge Perez Drive along side the Back Protection Levee from East/West Railroad Ditch(es) to Paris Road; culverts run under Paris Road; then the canal continues from Paris Road to Verret. It then continues from Verret to Caernarvon along side the Back Levee.

Delaronde Canal: Runs perpendicular to Judge Perez Drive from Golden Drive to the Forty Arpent Canal and is bounded by Delambert, Richelieu & Lavosier on the Westside (Paris Road side) and by an open field (next to Rosetta and Golden) on the Eastside (Violet side). Note: from St. Bernard

Hwy. to Judge Perez, which is to the rear of Pelitere, is covered with culverts and belongs to Parish.

Waterworks Ditch: Also known as the Palmisano Canal. Runs perpendicular to Judge Perez Drive from St. Bernard Hwy. to the Twenty Arpent Canal and is bounded on the Westside (Paris Road side) by Palmisano and by Pecan on the Eastside (Violet side).

Corinne Canal: Also known as the Chalona Canal & the Gallo Canal. Runs perpendicular to Judge Perez Drive from St. Bernard Hwy. to the Forty Arpent Canal and is bounded on the Westside (Paris Road side) by Chalona and by Gallo on the Eastside (Violet side).

Kierr Canal: This canal is completely covered. Runs perpendicular to Judge Perez Drive beginning at Judge Perez and continuing

to the Twenty Arpent Canal and is bounded on the Westside (Paris Road side) by Corinne and on the Eastside (Violet side) by Campagna.

Meraux Canal: Runs perpendicular to Judge Perez Drive from the Mississippi River Levee to the Twenty Arpent Canal and continues to the Forty Arpent Canal. Runs through Murphy Oil; no homes involved. Murphy maintains between St. Bernard Hwy. and Judge Perez Drive; from Judge Perez Drive to the Forty Arpent Canal it is bounded by wooded/swamp area.

DeBouchel Canal: Runs perpendicular to Judge Perez Drive beginning at Judge Perez Drive and continuing to the Forty Arpent Canal and is bounded on the Westside (Paris Road side) by St. Marie and by wooded area on the Eastside (Violet side)/ no street.

Lower Dockville Canal: Runs perpendicular to Judge Perez Drive from St. Bernard Hwy. to the Forty Arpent Canal. Between St. Bernard Hwy. and Judge Perez Drive, it is bounded on the Westside (Paris Road side) by wooded area (Meraux Pasture) and by Edgar on the Eastside (Violet side). Between Judge Perez Drive and the Forty Arpent

Canal, it is bounded on the Westside (Paris Road side) by wooded area and by Shannon Drive on the Eastside (Violet side).

Violet Ditch:Runs perpendicular to Judge Perez Drive from the Twenty Arpent Canal to the Forty Arpent Canal behind Colonial Boulevard. It is wooded on both sides.

Intercepting Canal:Also known as the Twenty Arpent Canal. Runs parallel to Judge Perez Drive and is located between Judge Perez Drive and the Forty Arpent Canal beginning at the Delaronde Canal (near Golden Drive) and continuing to the Violet Canal (behind Oakridge Subdivision). All of the canals flowing in a northerly direction intersect with this canal.

Green Avenue Ditch:Begins at St. Bernard Hwy. in Poydras near Farmsite; runs along Green Avenue through Christie Park, Plantation Village, and Torres Drive Subdivisions and continues under Judge Perez Drive to the E.J. Gore Pumping Station.

Riverbend Canal:Belongs to the Parish. Runs from St. Bernard Hwy to the Forty Arpent Canal between Riverbend and Reunion.

South Lake Estates:Retention pond and canal belong to the Parish.

Bayou Terre Beouf:Belongs to the Parish. Runs along side Bayou Road (LA 46) from Poydras to Verret.

St. Bernard Hwy. Ditch:Belongs to State of Louisiana. Runs along side St. Bernard Hwy. from the Eickes Canal to Paris Road.

Canal (Name Unknown):Runs perpendicular to Judge Perez Drive from St. Bernard Hwy. to Judge Perez Drive and is bounded on the Westside (New Orleans side) by an open field (Meraux property) and by Pirate Drive on the Eastside (Paris Road side).

Fortification Canal:From 8th Street to St. Bernard Hwy. belongs to the Parish and is bounded by Congressman Hebert and West Claiborne Square on the Eastside (Paris Road side) and by Chalmette Avenue on the Westside (New Orleans side).

Note: from 8th Street to the Bluebird Lateral Canal belongs to Lake Borgne Basin Levee District and is bounded by Artillery on the Eastside (Paris Road side) and by Andrew Jackson High School on the Westside (New Orleans side).

Creely Canal:Also known as Tiger Town Canal. Runs from the Bluebird Lateral Canal to St. Bernard Hwy and is bounded by Andrew Jackson High School and Artillery on the Eastside (Paris Road side) and by Creely on the Westside (New Orleans side).

Jacob Canal:Runs perpendicular to Judge Perez Drive beginning at Judge Perez Drive and continuing to the Twenty Arpent Canal. It is bounded by Murphy Oil on the Eastside (Violet side) and by Jacob Drive on the Westside (Paris Road side).

Three Canals

(Names Unknown):Run perpendicular to Judge Perez Drive beginning at Judge Perez Drive and continuing to the Twenty Arpent Canal. The first is across from Delchamps; the second is across from Blockbuster Video; the third is across from K-Mart.

Riverbend Canal:Runs from St. Bernard Hwy. to the Forty Arpent Canal between Riverbend and Reunion.

Canal (Name Unknown):Runs perpendicular to St. Bernard Hwy. and is bounded on the Eastside by Centenni Drive and by Serpas on the Westside.

South Lake Estates:Retention pond and canal are located behind the houses in South Lake Estates and along side River Park and River Queen Subdivisions.

Bayou Terre Beouf:Runs along side Bayou Road (LA 46) from Poydras to Verret.
