EXTRACT OF THE OFFICIAL PROCEEDINGS OF THE COUNCIL OF THE PARISH OF ST. BERNARD, STATE OF LOUISIANA, TAKEN AT A REGULAR MEETING HELD IN THE COUNCIL CHAMBERS OF THE ST. BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, AUGUST 5, 2014 AT SEVEN O'CLOCK P.M.

On motion of Mr. Lewis, seconded by Mr. Hunnicutt, it was moved to adopt the following ordinance:

EMERGENCY ORDINANCE SBPC #1532-08-14

AN ORDINANCE TO EXTEND THE CURRENT CONTRACT WITH ACADIAN AMBULANCE FOR SIXTY DAYS TO FACILITATE THE PROCUREMENT OF A NEW CONTRACT.

WHEREAS, the Governing Authority, wishes to extend the current contract with Acadian Ambulance Service for ambulance services for St. Bernard Parish for a period of sixty (60) days; and,

WHEREAS, this would allow St. Bernard Parish Government time to negotiate a new contract with Acadian Ambulance while maintaining the current contract for ambulance services; and,

WHEREAS, the St. Bernard Parish Council, the Governing Authority, does hereby express and declare the importance of this emergency ordinance being enacted.

THE ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The St. Bernard Parish Council, the Governing Authority, does hereby ordain that the current contract with Acadian Ambulance is extended for sixty days to allow St. Bernard Parish Government the time to facilitate the procurement of a new contract.

SECTION 2. Effective Date. This ordinance shall become effective immediately upon authorizing signature by the Parish President. If the proposed ordinance is not signed or vetoed by the Parish President within Twelve (12) hours after receipt it shall be considered adopted. As an emergency ordinance the provisions shall remain valid for a time period of sixty (60) days.

The above and foregoing having been submitted to a vote, the vote there upon resulted as follows:


