## RESOLUTION SBPC #1181-05-14

A RESOLUTION REQUESTING APPROVAL TO ALLOCATE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) DISASTER RECOVERY MONIES FOR MAINTENANCE OF THE NON-LOUISIANA LAND TRUST (LLT) PROPERTIES.

**WHEREAS**, the Office of Community Development has made available funding through the Louisiana Community Development Block Grant (CDBG) Disaster Recovery Program administered by the Division of Administration to assist St. Bernard Parish impacted by Hurricanes Katrina and Rita in implementing ongoing and planned recovery projects; and,

**WHEREAS**, the Department of Housing & Urban Development regulations require that the St. Bernard Parish Council certify that these activities for which CDBG funds are being requested are designed to alleviate existing conditions which pose a serious and immediate threat to the health or welfare of the community; which are of recent origin or which recently became urgent; and,

**WHEREAS**, the maintenance of non-LLT lots has added to blight in our neighborhoods, diminishes the quality of life in St. Bernard Parish, and is having a negative impact on the Parish's ability to maintain public properties; and,

**WHEREAS**, the St. Bernard Parish Council supports this utilization of funding in order to protect the quality of life in the Parish and reduce blight in recovering neighborhoods.

**NOW THEREFORE BE IT RESOLVED**, that the St. Bernard Parish Council, does hereby request approval from the Office of Community Development to use CDBG Disaster Recovery funds for the maintenance of non-LLT properties in St. Bernard Parish.
