On motion of the Chair, without objection and by unanimous consent it was moved to **remove** the following resolution:

### RESOLUTION SBPC #1663-12-16

A RESOLUTION AUTHORIZING THE ACCEPTANCE OF A GRANT FROM THE LOUISIANA DECENTRALIZED ARTS FUNDING PROGRAM IN THE AMOUNT OF \$1,023.00 FOR THE JAZZ IN JUNE CONCERT AT TORRES PARK

WHEREAS, the Louisiana Department of Culture, Recreation and Tourism, Division of the Arts, funds the Decentralized Arts Funding Program making grants available to nonprofit organizations, community groups, and local governmental agencies to produce cultural programs; and,

WHEREAS, the State of Louisiana has established an agreement with the St. Tammany Commission on Cultural Affairs to administer this program for the Parishes of St. Tammany and St. Bernard; and

WHEREAS, the Decentralized Arts Funding Program issued a call for FY2016-2017 grant applications; and

WHEREAS, St. Bernard Parish Council authorized submission of a \$5,000 grant application to fund the Jazz in June Concert Series by Council resolution in May, 2016; and

WHEREAS, limited funding is available for this program and more applications were received than could be funded; and

WHEREAS, the Decentralized Arts Funding Program has offered reduced grant funding to St. Bernard Parish Government sufficient to cover one concert from the original proposal.

NOW THEREFORE BE IT RESOLVED the St. Bernard Parish Council, does hereby authorize acceptance of a grant from the Louisiana Department of Culture, Recreation and Tourism's Decentralized Arts Program, as administered by the St. Tammany Commission on Cultural Affairs, in the amount of \$1,023.00 in order to host a *Jazz in June* concert in Torres Park including the following additional stipulations:


